WHAT IS POCSO ACT ?





SHe-Box

4. The Ministry of Women and Child Development, Government of India has developed an online complaint management system titled **Sexual Harassment Electronic Box (SHe-Box)** for registering complaints related to sexual harassment at workplace by women, including government and private employees. Once a complaint is submitted to the SHe-Box portal, it directly reaches the concerned authority having jurisdiction to take action in the matter.
